- •Bharatiya Prakritik Krishi Paddhati (BPKP) Scheme is launched by Ministry of Agriculture & Farmers Welfare during 2020-21
- •Government is implementing this centrally sponsored scheme, Bhartiya Prakritik Krishi Padhati (BPKP) as a sub scheme of **Paramparagat Krishi Vikas Yojana (PKVY)** since 2020-21 for the promotion of traditional indigenous practices.







- o'Paramparagat Krishi Vikas Yojana' is a component of Soil Health Management (SHM) of National Mission of Sustainable Agriculture (NMSA).
- ■Under PKVY Organic farming is promoted through the adoption of the organic village by cluster approach and PGS certification.
- •This scheme aims to promote Natural Farming and traditional indigenous practices.







- •It mainly emphasizes on,
- oPromoting traditional indigenous practices which reduce externally purchased inputs;
- Exclusion of all synthetic chemical inputs;
- oPromoting on-farm biomass recycling with major stress on biomass mulching, use of cow dung-urine formulations, plant-based preparations and
- •Time to time working of soil for aeration (periodic soil aeration).
- •Under BPKP, financial assistance of **Rs. 12200/ha for 3 years** is provided for cluster formation, capacity building and continuous handholding by trained personnel, certification and residue analysis.









#### **Participatory Guarantee Scheme**

- PGS is a process of certifying organic products, which ensures that their production takes place in accordance with laid-down quality standards.
- The certification is in the form of a documented logo or a statement.
- Under the Ministry of Agriculture's Department of Agriculture and Co-operation.
- Organic foods are also required to comply with the requirements of labeling of FSSAI in addition to that of NPOP or PGS-India.

### 2. PMFBY



- Central Government's flagship crop insurance scheme launched in 2016
- It replaced the earlier two schemes National Agricultural Insurance Scheme and Modified NAIS
- Aims to provide insurance and financial support to farmers in the event of crop failure and targets to bring 50% of cultivated area under crop insurance
- Scheme was made voluntary for all farmers(which was one of the challenges in success of the scheme) after its revamp in February 2020.

### 2. PMFBY



- Further, the states have also been provided flexibility to rationalise the sum insured so that adequate benefit can be availed by farmers
- All farmers growing notified crops in a notified area during the season who have insurable interest in the crop are eligible
- Coverage of Crops: State government notifies major crops for the Rabi and Kharif seasons
- Farmers pay just 1.5% premium for rabi, 2% premium for kharif and 5% for commercial crops

### 2. PMFBY



- All farmers in a particular area must pay the same premium and have the same claim payments
- It aims to prevent sowing/planting risks, loss to standing crop, postharvest losses and localised calamities (no revenue protection)

# 3. National Mission on Edible Oil-Oil Palm (NMEO-OP)



- Aims for self-reliance in edible oil involves investment of over Rs. 11,000 crore (over a five year period)
- NMEO proposal would aim to reduce import dependence from 60% to 45% by 2024-25, by increasing domestic edible oil production from 10.5 million tonnes to 18 million tonnes, a 70% growth target
- The special emphasis of the scheme will be in India's north-eastern states and the Andaman and Nicobar Islands due to the conducive weather conditions in the regions





# 3. National Mission on Edible Oil-Oil Palm



### (NMEO-OP)

- Under the scheme, oil palm farmers will be provided financial assistance and will get remuneration under a price and viability formula
- India is the largest consumer of vegetable oil in the world.
- Of this, palm oil imports are almost 55% of its total vegetable oil imports
- Palm oil is currently the world's most consumed vegetable oil.



# 3. National Mission on Edible Oil-Oil Palm (NMEO-OP)



- It is used extensively in the production of detergents, plastics, cosmetics, and biofuels.
- Top consumers of the commodity are India, China, and the European Union (EU)
- India produces less than half of the roughly 2.4 crore tonnes of edible oil that it consumes annually.
- It imports the rest, buying palm oil from Indonesia and Malaysia, soy oil from Brazil and Argentina, and sunflower oil, mainly from Russia and Ukraine
- Some groups are opposing this move as Oil palm is an invasive species.



### 4. PM PRANAM

- •PM PRANAM stands for PM Promotion of Alternate Nutrients for Agriculture Management Yojana.
- •Aim: The proposed scheme intends to reduce the subsidy burden on chemical fertilizers, which is expected to increase to Rs 2.25 lakh crore in 2022-2023.
- This is 39% higher than the previous year's figure of Rs 1.62 lakh crore.
- The scheme will not have a separate budget and will be financed by the "savings of existing fertiliser subsidy" under schemes run by the Department of Fertilizers.
- Further, 50% subsidy savings will be passed on as a grant to the state that saves the money.



### 4. PM PRANAM

- 70% of the grant provided under the scheme can be used for asset creation related to technological adoption of alternate fertilizers and alternate fertilizer production units at village, block and district levels.
- The remaining 30% grant money can be used for incentivizing farmers, panchayats, farmer producer organisations and self-help groups that are involved in the reduction of fertiliser use and awareness generation.
- The government will compare a state's increase or reduction in urea in a year, to its average consumption of urea during the last three years. Data available on a fertiliser Ministry dashboard, iFMS (Integrated fertilisers Management System), will be used for this purpose.



### 4. PM PRANAM

- 70% of the grant provided under the scheme can be used for asset creation related to technological adoption of alternate fertilizers and alternate fertilizer production units at village, block and district levels.
- The remaining 30% grant money can be used for incentivizing farmers, panchayats, farmer producer organisations and self-help groups that are involved in the reduction of fertiliser use and awareness generation.
- The government will compare a state's increase or reduction in urea in a year, to its average consumption of urea during the last three years. Data available on a fertiliser Ministry dashboard, iFMS (Integrated fertilisers Management System), will be used for this purpose.



### 5. One Nation -One Fertiliser

- Implemented under Pradhan Mantri Bhartiya Jan Urvarak Pariyojana (PM-BJP).
- Under ONOF companies are allowed to display their name, brand, logo and other relevant product information only on one-third space of their bags.
- On the remaining two-thirds space, the "Bharat" brand and Pradhan Mantri Bharatiya Jan Urvarak Pariyojana logo will have to be shown.





### 5. One Nation -One Fertiliser

- The single brand name for UREA, Di-Ammonium Phosphate DAP, Muriate of potash (MOP) and Nitrogen Phosphorus Potassium NPK etc. would be BHARAT UREA, BHARAT DAP, BHARAT MOP and BHARAT NPK etc. respectively for all Fertiliser Companies, State Trading Entities (STEs) and Fertiliser Marketing Entities (FMEs)
- This scheme applies to both public and private sector companies





### 5. One Nation -One Fertiliser

- It will bring about uniformity in fertiliser brands across the country
- All subsidised soil nutrients urea, di-ammonium phosphate (DAP), Muriate of Potash (MoP), and NPK will be marketed under the single brand Bharat across the nation
- Recently Government launched 'Indian Edge', an emagazine on fertiliser.









## Samudrayan Mission under DOM

- A manned submersible will be developed to carry three people to a depth of 6,000 metres in the ocean with a suite of scientific sensors and tools.
- An integrated mining system will be also developed for mining polymetallic nodules at those depths in the central Indian Ocean.
- India has been allotted a site of 75,000 square kilometres in the Central Indian Ocean Basin (CIOB) by the UN International SeaBed Authority for exploitation of polymetallic nodules (PMN).
- These are rocks scattered on the seabed containing iron, manganese, nickel and cobalt
- Being able to lay hands on a fraction of that reserve can meet the energy requirement of India for the next 100 years, say officials at the Earth Sciences Ministry





### Deep Ocean Mission

- The First Component involves a manned submersible vehicle developed to carry three people to a depth of 6000 metres in the ocean.
- The second component involves developing Ocean Climate Change Advisory Services, which entails developing a suite of observations and models to understand and provide future projections of important climate variables on seasonal to decadal time scales.
- The Third component is searching for deep sea flora and fauna, including microbes, and studying ways to sustainably utilise them.





### Deep Ocean Mission

- The fourth component is to explore and identify potential sources of hydrothermal minerals that are sources of precious metals formed from the earth's crust along the Indian Ocean mid-oceanic ridges
- The fifth component involves studying and preparing detailed engineering design for offshore Ocean Thermal Energy Conversion (OTEC) powered desalination plants.
- The sixth component is aimed at grooming experts in the field of ocean biology and engineering. This component aims to translate research into industrial applications and product development through on-site business incubator facilities

## 6. 'Samagra Shiksha Scheme 2.0'

- The Centre has approved the continuation of the 'Samagra Shiksha Scheme' for school education for the next five years till March 31, 2026.
- The scheme has been revamped with the addition of new Components/initiatives based on the recommendations of the NEP 2020.





# 6. 'Samagra Shiksha Scheme 2.0'

Components of the Samagra Shiksha Abhiyan (SSA) 2.0:

- 1. In order to enhance the direct outreach of the scheme, all child-centric interventions will be provided directly to the students through DBT [or direct benefit transfer] mode on an IT based platform over a period of time.
- 2. This DBT would include RTE entitlements such as textbooks, uniforms and transport allowance.





# 6. 'Samagra Shiksha Scheme 2.0'

Components of the Samagra Shiksha Abhiyan (SSA) 2.0:

- 3. Keeping with the NEP's recommendations on encouraging Indian languages, it has a new component for appointment of language teachers, which includes salaries, and training costs as well as bilingual books and teaching learning material.
- 4. It will have the NIPUN Bharat initiative for foundational literacy and numeracy.





# 6. 'Samagra Shiksha Scheme 2.0'

Components of the Samagra Shiksha Abhiyan (SSA) 2.0:

- 5. As part of digital initiatives, there is a provision for ICT labs and smart classrooms, including support for digital boards, virtual classrooms and DTH channels.
- 6. It includes a provision to support out of school children from age 16 to 19 with funding to complete their education via open schooling.
- 7. It also has a provision for an incentive of up to ₹25000 for schools that have two medal winning students at the Khelo India school games at the national level.



# 7. 'Samagra Shiksha Scheme 2.0'

It subsumes the three Schemes of Sarva Shiksha Abhiyan (SSA), Rashtriya Madhyamik Shiksha Abhiyan (RMSA) and Teacher Education (TE).





#### 8. PM SHRI



- The Union Cabinet approved the 'PM Schools for Rising India' (PM SHRI) scheme to turn existing government schools into model schools.
- It will showcase all components of the National Education Policy 2020, act as exemplary schools and also offer mentorship to other schools in their vicinity.
- The scheme will be implemented as a <u>Centrally</u> <u>sponsored scheme</u> with a total project cost of 27,360 crore for the period of five years from 2022-23 to 2026-27 for transforming nearly 14,500 schools across the country.

#### 8. PM SHRI



- A 'School Quality Assessment Framework' is being developed to measure the progress and performance of these schools.
- It will provide high-quality education in an "equitable, inclusive and joyful environment that takes care of the diverse background, multilingual needs and different academic abilities of children".
- Development of 'Green schools': These will be equipped with solar panels, LED lights, nutrition gardens, and waste management, water conservation and harvesting systems.

#### 9. PM YUVA 2.0



- The Prime Minister's Scheme for Mentoring Young Authors, known as YUVA 2.0 (Young, Upcoming and Versatile Authors), was launched by the Department of Higher Education of the Ministry of Education on October 2
- YUVA (Young, Upcoming and Versatile Authors) 2.0 is an Author Mentorship programme to train authors (below 30 years of age)

#### 9. PM YUVA 2.0



- It aims to promote reading, writing and book culture in the country and project India and Indian writings globally
- The National Book Trust (NBT), India, under the Ministry of Education as the Implementing Agency will ensure phase-wise execution of the Scheme under well-defined stages of mentorship
- It is a part of India@75 Project (Azadi Ka Amrit Mahotsav).







- Ministry of Education
- Vidyanjali is an initiative with the aim to strengthen Schools through community and private sector involvement in schools across the country
- This initiative would connect schools with varied volunteers from the Indian Diaspora namely, young professionals, school alumni, in service and retired teachers / Government officials / professionals and many others
- Vidyanjali, which is being implemented under the overall aegis of the Samagra Shiksha will enhance the community involvement in Government schools









- The volunteers can register for free by visiting through the mobile app
- Programme is unique which gives the freedom to the volunteers to design their activities in consultation with the school
- Vidyanjali 2.0 Portal will facilitate donations, contributions from Corporate Social Responsibility funds, and volunteering, all aimed at developing and improving schools



#### 11. PM POSHAN



- Pradhan Mantri Poshan Shakti Nirman (Mid Day Meal).
- Centrally Sponsored Scheme.
- There is provision of hot cooked meal to children of preschools or Bal Vatika (before class I) in primary schools also in addition to the 11.80 crore children of classes I to VIII studying in 11.20 lakh schools.







- Food Grains: Supply of food grains @ 100 grams per child per school day for primary and 150 grams for upper primary at NFSA rate i.e. ₹ 1 per kg for coarse grains, ₹ 2 per kg for wheat and ₹ 3 per kg for rice.
- Cooking Cost: It includes cost of ingredients, e.g. pulses, vegetables, cooking oil, other condiments and fuel. The per child per day cooking cost is ₹ 4.97 for primary and ₹ 7.45 for upper primary w.e.f. 1st April, 2020.
- Honorarium to Cook-cum-Helpers: @ ₹ 1000 per month for 10 months in a year.





- Transportation Assistance: As per PDS rate for transportation of food grains from FCI godown to school door steps. Maximum₹ 1500 per MT for transportation of food grains from FCI godown to school door steps for States other than NER and 2 Himalayan States and 2 UTs.
- Management, Monitoring and Evaluation (MME): @ 3% of aggregate of cost of foodgrains, cooking cost, Honorarium to Cook-cum-Helpers and Transportation Assistance.
- Provision of Meals during summer vacations in drought/ disaster affected areas.





- Kitchen-cum-store: As per plinth area norm and State Schedule of Rates. 20 sq meter for schools having enrolment of 100 students. Additional 4 sq meter for every addition of up to 100 students.
- Kitchen devices: Linked with enrolment.
- Repair of kitchen-cum-stores: ₹ 10,000/- per unit, for the kitchen-cum-stores, which were constructed 10 years ago.
- Fortification of food items: Fortification of food items in a systematic manner through Food Corporation of India (FCI







# Ministry of Environment, Forest and Climate Change Government of India





## 12. National Clean Air Program

In January 2019, the Ministry of Environment, Forest and Climate Change (MoEFCC) launched the National Clean Air Programme (NCAP) to prepare clean air action plans.

The mandate of the National Clean Air Programme (NCAP); –

The goal of NCAP (annual average ambient air quality standards at all locations in the country): 20%–30% reduction of PM2.5 and PM10 concentration by taking 2017 as the base year for the comparison of concentration.

Under NCAP, 132 non-attainment cities have been identified across the country based on the Air Quality data from 2014-2018.







### 12. National Clean Air Program

Preparation of the city-specific action plans including measures to strengthen the monitoring network, reduce vehicular/industrial emissions, and increase public awareness.

Implementation of the city-specific action plans to be regularly monitored by Committees at the Central and State level namely Steering Committee, Monitoring Committee and Implementation Committee.







#### **Objectives of NCAP**

- To augment and evolve effective and proficient ambient air quality monitoring networks across the country for ensuring a comprehensive and reliable database
- To have efficient data dissemination and public outreach mechanism for timely measures for the prevention and mitigation of air pollution
- To have a feasible management plan for the prevention, control and abatement of air pollution.





#### Recent changes

The Centre has set a new target of **a 40% reduction** in particulate matter concentration in cities covered under the National Clean Air Programme (NCAP) by 2026, updating the earlier goal of 20 to 30% reduction by 2024.

According to the Union Environment Ministry, 95 of the 131 non-attainment cities covered under the NCAP have witnessed an "overall improvement" in PM10 levels in 2021 as compared to 2017 levels.

The acceptable annual standard for PM2.5 is 40 micrograms per cubic metre.







#### • Performance of National Clean Air Programme:

#### Positive

- Monitoring station: Out of the targeted 1500 manual monitoring stations to be installed across the country, 818 have been installed.

#### 14. ECLGS



- Emergency Credit Line Guarantee Scheme = ECLGS (launched in May 2020) as part of the Centre's Atma Nirbhar package in response to the Covid-19 crisis.
- It is aimed at giving the necessary collateral free liquidity loans at reasonable interest rates (and 4-year timeline for reimbursement) to support small businesses struggling and other sectors including aviation
- 100% guarantee is provided by the National Credit Guarantee Trustee Company (NCGTC) to Member Lending Institutions (MLIs) – banks, financial institutions and Non-Banking Financial Companies (NBFCs)

#### 14. ECLGS



- First-time borrowers and Non Performing Asset (NPA) accounts cannot raise funds under the scheme
- Recently, Department of Financial Services (DFS) (under the finance ministry) has modified the Emergency Credit Line Guarantee Scheme (ECLGS) for the aviation sector, to help the sector tide over cash-flow problems

- India has the world's highest tuberculosis (TB) burden, with an estimated 26 lakh people contracting the disease and approximately 4 lakh people dying from the disease every year.
- The Ministry of Health and Family Welfare (MoHFW) is implementing an ambitious National Strategic Plan with the goal to achieve SDG End TB targets by 2025.

#### **Objectives:**

- Provide additional patient support to improve treatment outcomes of TB patients
- Augment community involvement in meeting India's commitment to end TB by 2025.
- Leverage Corporate Social Responsibility (CSR) activities.







#### **Components:**

- Ni-kshay Mitra Initiative: It is to ensure additional diagnostic, nutritional, and vocational support to those on TB treatment.
- Ni-kshay Mitra (Donor) are those who can support by adopting health facilities (for individual donor), blocks/urban wards/districts/states for accelerating response against TB to complement government efforts.
- **Ni-kshay Digital Portal:** It will provide a platform for community support for persons with TB.





India's National TB Elimination Programme is strengthened to meet the goal of ending the TB epidemic by 2025 from the country, five years ahead of the Sustainable Development Goals (SDG) for 2030.

National Strategic Plan (NSP) for Tuberculosis Elimination (2017-2025), The Nikshay Ecosystem (National TB information system), Nikshay Poshan Yojana (NPY- financial support), TB Harega Desh Jeetega Campaign.





- Currently, two vaccines VPM (Vaccine Projekt Management) 1002 and MIP (Mycobacterium Indicus Pranii) have been developed and identified for TB, and are under Phase-3 clinical trial.
- Ni-kshay Poshan Yojana: It provides Rs 500 support through direct benefit transfer to the patients.
- Ayushman Bharat Digital Health Mission: The government has also focused on utilising technology and creating digital health IDs for TB patients under the Ayushman Bharat Digital Health Mission to ensure proper diagnostics and treatment are available



- •The Department of Science and Technology (DST) also launched Material Acceleration Platforms (MAP), which will leverage emerging capabilities in next-generation computing, Artificial Intelligence (AI) and machine learning, and robotics to accelerate the pace of materials discovery up to ten times faster.
- •The objective of Mission Integrated Bio-refineries is to develop and demonstrate innovative solutions to speed the commercialization of integrated biorefineries, with the goal of replacing 10% of fossilbased fuels, chemicals, and materials with bio-based alternatives by 2030.





#### What is meant by Mission Integrated Bio-refineries?

- India and the Netherlands are co-leading the mission. Brazil and Canada are also core members, with the European Commission and the United Kingdom serving as supporting members.
- This is Mission Innovation's sixth mission, joining initiatives focused on clean hydrogen, net-zero shipping, green power systems, carbon dioxide removal, and urban transitions.
- It will enhance sustainable biorefining pathways and technologies to aid in the development and commercialization of bio-based fuels, chemicals, and materials while also taking process energy demands into consideration.







- This will help to de-risk new and emerging technology while also boosting the cost-competitiveness of bio-based alternatives, particularly biofuels.
- The Mission brings together a dynamic and results-oriented partnership of countries, international organizations, the corporate sector, academic institutions, and civil society to accelerate innovation for low-carbon fuels, chemicals, and materials.
- Through Public-Private Alliances, it will accelerate Clean Energy solutions.



- Encourage R&D and innovation throughout the biorefining supply and value chain.
- Advanced Pilot-scale demonstration projects for sustainable biorefining technology.
- Collaborate with the industry and standards-setting organizations to aid in the creation of regulatory developments for these new products.







- Biotech-PRIDE (Promotion of Research and Innovation through Data Exchange) Guidelines" developed by Department of Biotechnology (DBT),
- + Term biological data includes, inter alia, DNA sequence data, RNA sequence transcriptomic data, Genotype data, Epigenomic data and protein structure data
- guidelines have been formulated in conformity with the principles of NDSAP (National Data Sharing and Accessibility Policy) 2012, for enabling the sharing, access and storage of biological data

#### 26. Biotech-PRIDE



- At present, in India the biological data is deposited in International Repositories and there are no guidelines for sharing it
- Under the guidelines, it is the responsibility of the data generator to deposit data in an appropriate database in the notified Data Repository
- These Guidelines will be implemented through Indian Biological Data Centre (IBDC) at Regional Center for Biotechnology supported by Department of Biotechnology.
- Other datasets/ data centres will be bridged to the IBDC which will be called Bio-Grid
- The Bio-Grid will be a National Repository for all biological knowledge, information and data generated through research within the country.
