- Q.1 Growth and equality are often argued to be in conflict. Can you think of cases where the opposite is true, namely transfers to the poor can promote economic growth? Discuss these with appropriate examples.
- Q.2 The public distribution system makes *in-kind* transfers of grains to households. What are some reasons for these types of transfers rather than cash transfers to the same households?
- Q.3 Is economic liberalization policy a panacea for all kinds of problems which persist in the Indian economy? Discuss.
- Q.4 Describe the status of irrigation in the Indian agriculture mentioning its regional variations.
- Q.5 Why must future expansions in agricultural output focus on yields rather than cultivable area expansions and what types of state policies have been successfully used for higher yields? How can better communication strategies with farmers help in this regard?
- Q.6 International Banks or financial agencies have been found involved in laundering of black money raised through illegal activities such as drug/narcotics trafficking, forged invoicing, extortion and kidnapping for ransom to name a few of the ways through which they generate cash to finance their deadly deeds. Would a blanket ban on such agencies solve the problem? Critically examine.
- Q.7 Discuss the role of electronic media and social networking sites in the context of internal security by highlighting both positive and negative aspects?
- Q.8 Throw light on the role played by external, state and non-state actors in threatening national security?
- Q.9 Internal security problems could be placed in two categories: (a) border state problems and (b) core state problems. Identify essential differences between the two and suggest remedial measures.
- Q.10 "There is not an iota of doubt that a definite linkage do prevail between development and spread of extremism". Elucidate.
- Q.11 The average kilometer per liter of a particular Sedan are 20, 22, 23, 22, 23, 22, 22, 21, 19, 22, 22, 26, 23, 24, 19, 21, 22, 16
  - Calculate mean, median and mode.
  - Compute variance, standard deviation and range.
- Q.12 For few products, the corresponding calories and fat contents are given in the following table. Calculate the correlation. Comment on your findings.

| Starbucks Chocolate Frappuccino Blended Creme (whipped cream)          | 530      | 19.0 |

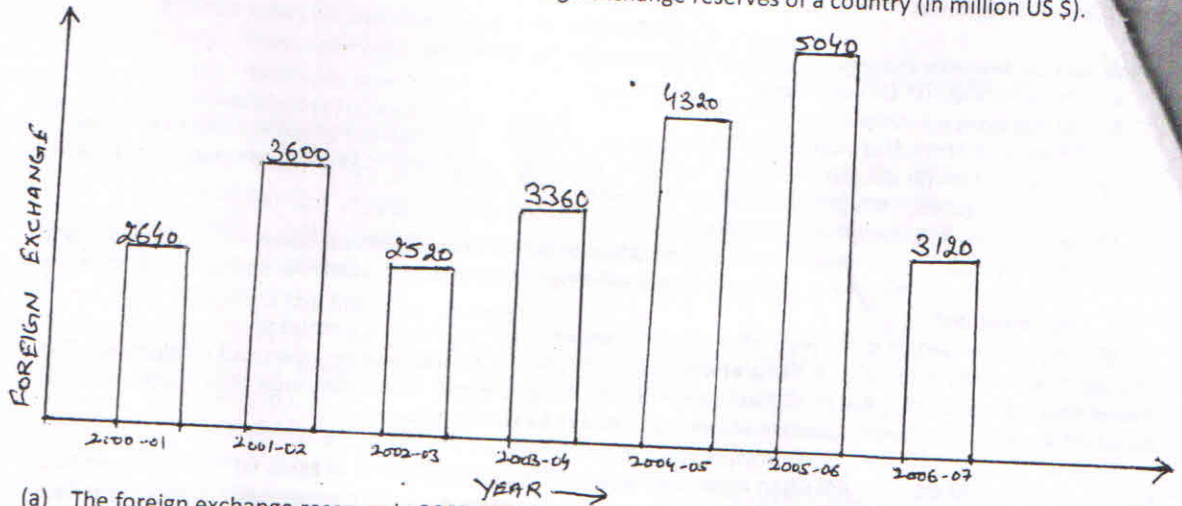
- Q.13 Given below is the data of an electoral constituency in Bihar:

- If all other communities come together can are they likely to defeat a Hindu candidate?



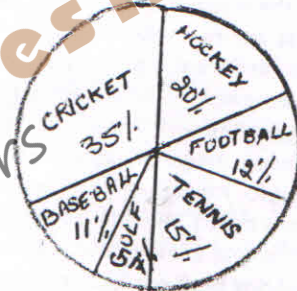
Q.14 The bar diagram given below shows the foreign exchange reserves of a country (in million US \$).
